



FITTING INSTRUCTIONS FOR LP0054BK TAIL TIDY (LICENCE PLATE HOLDER)

DUCATI HYPERMOTARD 1100 07'



Images shown with R&G Mini Indicators fitted – see product code RG370

Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

- **NOTE YOU WILL NEED TO GLUE THE LIGHT SHROUD TO THE LED LICENCE PLATE LIGHT USING A SMALL AMOUNT OF SUPER GLUE.**
- Undo the fixings holding the tail unit to the bike, unplug wiring & remove tail unit
- Assemble the R&G number plate light to the diamond shaped part of the tail tidy then assemble the two parts of the unit together using the four black M6 button head bolts.
- Fit the indicators of your choice, if using the OEM indicators use the two clamps supplied (R&G mini indicators are available – see our product code RG370).
- Take the R&G licence plate holder & fit to the bike using the four OEM bolts & tighten.
- To reconnect wiring cut the OEM plug from the OEM number plate light and splice to the R&G unit with the connectors supplied. Do the same with the indicators if using aftermarket.
- When all the wires are connected fit the cover to the tail tidy using the three black M6 button head bolts.

R&G RACING RETURNS POLICY (NON-FAULTY GOODS)

Returns must be pre-authorized (if not pre-authorized the return will be rejected). Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor. Goods must be in re-sellable condition, in the opinion of R&G Racing. All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.
