


# FITTING INSTRUCTIONS FOR FP0105 FORK-PROTECTORS SUZUKI GSR750 2011



## LEGEND

 $\overline{\text{ITEM 1}} = \overline{\text{M8}} \text{ NYLOC NUTS (x2)}.$ 

ITEM 2 = M8 WASHERS (19mm OUTSIDE DIAMETER) (x2).

ITEM 3 = CRASH PROTECTORS (B0445 M) (x2).

ITEM 4 = LEFT-HAND SPACER (S0444) (x1).

ITEM 5 = RIGHT-HAND SPACER (S0445) (x1).

ITEM 6 = SPINDLE BAR (SB027---311mm LONG) (x1).

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away*!

### TOOLS REQUIRED

• TWO 13mm A/F SOCKETS AND WRENCHES.

## FITTING INSTRUCTIONS

- PLACE SMALLER SPACER (S0444) INTO LEFT-HAND FRONT SPINDLE.
- PLACE LARGER SPACER (S0445) INTO RIGHT-HAND FRONT SPINDLE.
- FEED SPINDLE-BAR (SB027) THROUGH SPACERS IN FRONT SPINDLE.
- FIT BOTH CRASH-PROTECTORS OVER EITHER END OF SPINDLE BAR.
- FIT WASHERS AND NYLOC NUTS ONTO EITHER END OF SPINDLE BAR.
- TIGHTEN UNTIL BOTH NUTS ARE ENGAGED IN NYLON AND EQUAL AMOUNTS PROTRUDE FROM EITHER SIDE. DO NOT OVER-TIGHTEN—THE NYLOC NUTS WILL HOLD IT TIGHT.



Article 2 = rondelles M8 (19mm diamètre extérieur)

Article 4 = Entretoise de gauche (S0444) (x1).

Article 5 = Entretoise de droite (\$0445) (x1).

Article 6 = (SB027 --- 311mm LONG) (x1).

- Installer les rondelles et ecrous Nyloc.
   Serrer de facon a ce que les ecrous depassent d'une longueur egale de chaque cote.
