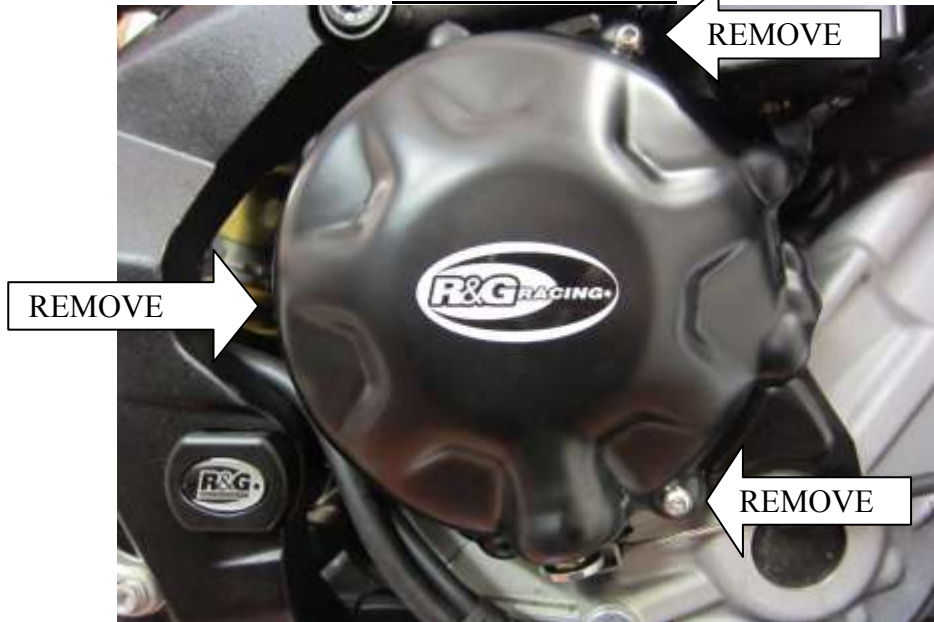




FITTING INSTRUCTIONS FOR ECC0147 RHS CLUTCH CASE COVER
MV AGUSTA F3 2012



In this kit there should be:
1 x Engine Case Cover (ECC0147)
3 x M6x35mm long button head bolts

PLEASE READ THESE INSTRUCTIONS FULLY BEFORE STARTING

- Please make sure the engine is cold before proceeding with the fitting of the R&G cover.
- To fit the R&G clutch case cover remove the three T27 Torx engine case bolts in the positions arrowed above. Hold the cover loosely over the case to help identify the correct ones. **DO NOT REMOVE ALL OF THE CASE BOLTS.**
- Offer up the R&G cover to the engine and carefully fit it over the clutch casing. Ensure that the three R&G bolts are lined up with the holes in the engine casing, and then push on as far as it will go.
- Fit the bolts through the Engine Case Cover and into the engine case.
- With a 4mm Allen key tighten the bolts equally so that they pull the cover into place. **DO NOT FULLY TIGHTEN.**
- Finally use a torque wrench set at 10 nm (7 Lb ft) to fully tighten.
- It is suggested that you check the tightness of the mounting bolts on a regular basis i.e. when cleaning or once a month.
- NOTE for the cleaning of this product you should only use a soft polishing cloth and a mild general cleaning agent.
- **AVOID HARMFUL CHEMICALS. IF IN DOUBT DO NOT USE AS THEY COULD ALTER THE STRENGTH OF THE COVER.**
- R&G will accept no liability if the above procedure and torque settings are not followed.

Instructions de montage pour ECC0147 Protection Carter moteur coté droit
MV AGUSTA F3 2012



Le kit doit contenir:

- 1 x Protection carter moteur (ECC0147)
- 3 x M6x35mm Boulons à tête ronde

Lisez attentivement ces instructions avant de commencer le montage :

- Vérifier que le moteur soit froid avant de procéder au montage.
- Enlever les 3 boulons T27 Torx du carter moteur en positions indiquées ci dessus. Tenir la protection autour du carter pour vous aider à identifier les bons. **NE PAS ENLEVER TOUS LES BOULONS DE CARTER MOTEUR.**
- Monter la protection sur le moteur et poser le autour de l'emplacement d'embrayage. Assurez vous que les 3 boulons R&G soient alignés avec les trous dans le carter moteur, puis poussez le aussi loin que possible.
- Insérez les boulons à travers la protection carter moteur puis à travers le carter moteur lui-même.
- Serrer les boulons avec une clé Allen 4mm de façon égale de façon à ce qu'ils placent la protection correctement. **NE PAS BLOQUER.**
- Utiliser une clé dynamométrique à 10Nm (7 Lb ft) pour serrer complètement.
- L'équipe R&G Racing vous suggère de vérifier le serrage des boulons de fixation régulièrement, lorsque vous nettoyez la moto, au minimum une fois par mois.
- NOTE : Pour le nettoyage, nous vous conseillons d'utiliser un chiffon doux avec un agent nettoyant qui ne soit pas trop agressif (d'utilisation générale).
- **ATTENTION A NE PAS UTILISER DE PRODUITS CHIMIQUES AGRESSIFS. EN CAS DE DOUTE, NE PAS UTILISER L'AGENT EN QUESTION CAR IL POURRAIT ALTERER L'EFFICACITE DE LA PROTECTION.**
