

FITTING INSTRUCTIONS FOR ECS0074BK ENGINE CASE SLIDERS MV AGUSTA 675 BRUTALE '12 & 800 BRUTALE/RIVALE '13-(LEFT HAND SIDE ONLY)



Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away*!

Left-hand side (as you sit on bike)

- Remove two M6 bolts as positioned (arrowed) above.
- Insert new cap head screws with washers through slider.
- Offer up to bike.
- Tighten evenly to manufactures specified torque.
- Fit bubble sticker as shown above.

Notez que si les kits sont emballés avec des rondelles en caoutchouc servant à tenir les composants, ces rondelles doivent être jetées.

Coté droit assis sur la moto :

- Enlever les 2 boulons M6 indiqués au dessus.
- Insérer les nouvelles vis à tête en capuchon avec les rondelles à travers les sliders.
- Monter l'ensemble sur la moto.
- Serrer de façon égale aux couples d'usine adaptés.
- Mettre les stickers en gomme R&G.
